## **Noreen Barrett**Life of Adventure, Life of Service, Life of Courage

The subject of this month's "Meet Your Neighbor" profile, Noreen Barrett, also happens to be our new Brandywine Owners Association, Inc. President. Congratulations, Noreen, and new Board Members. Be sure to say "hi" when you "Meet Your Neighbor," Noreen Barrett!

The threads and themes that comes up when talking to Noreen Barrett (in addition to lots of laughter) is the courage of adventure through service: Service to others – and eventually, service to her own happiness. (Why is the journey to one's own happiness sometimes the hardest journey to take?)

Rollo May, the American existential psychologist and author of several books, said, "The opposite of courage in our society isn't fear, it's conformity."

So, what was the key to Barrett's courage? Finding herself.

"Really, to find true happiness, you have to find yourself," says Barrett.

Born in Dublin, Ireland, to a father who was a veterinary surgeon with a large practice, she grew up just outside Dublin in Dunboyne, County Meath. She went to an all girls, Catholic school that was located next to the famous Phoenix Park

(which Barrett highly recommends if you ever get the chance...the Guinness factory is in the vicinity as well).

Over the summers, she and her brother and sister would help their mom with the work of their dad's busy vet practice. When she graduated high school, she began working in an uncle's family business where she got into import/export and which took her back to live inside the city limits of Dublin. Barrett loved the city's vibrancy, and she enjoyed her work well enough, but a comment from a friend launched her into a new life that eventually led her to North Carolina.

The comment that changed Barrett's life forever was the advice of a friend, Ethel, who told her, "You've got to go out and do something different".

And "do different" she did!

She took her friend's admonition to heart and began to think about what she might want to do. She began to think about "doing something different" and opportunities began to show up.

Through a friend, she was invited to work with the Venture Scouts of Ireland. She was hired because she was firm and was someone the kids could relate to. "I like community involvement," says Barrett. "In some regards, that's how I got involved with Eckerd" (referring to Eckerd Kids).

She enjoyed her work with the Venture Scouts. So later, while spending some time in her "happy place" (i.e., at her sister's place in County Kerry), she saw an ad in the paper for a counselor with Eckerd Kids, and she applied. It was a long, arduous application process – and Barrett got the job! (It was this job that brought her here to eastern North Carolina.) She arrived at the Charlotte airport in November of 1989, and she's lived in North Carolina ever since.

It takes courage to leave your home to go live in a new country with a different culture. It takes even more courage when you're moving because you've decided to change jobs or careers. It's hard enough to change jobs as it is, and when Barrett took the job with Eckerd Kids, she was doing more than double duty on the "change" front since she was changing jobs, country, and culture.

She moved to the United States and was placed at the camp formerly located on Nine Mile Road.

It was while working with Eckerd Kids that Barrett met her husband, Keith. This began yet another adventure for Barrett. They were transferred to a different Eckerd camp, but eventually returned to Carteret County where they worked for Carteret Community Action, now called Coastal Community Action. It was this work that led them to found East Carolina Community Development, Inc. which works to provide affordable housing. Their very first project was Camellia Court on Country Club Road.

Barrett worked with her husband and volunteered at her daughters' school, St. Egbert, where she met many dear, lifelong friends. Barrett had a great life, a marriage, two lovely daughters and a successful business, but Barrett wasn't happy. Something wasn't quite right, and Barrett couldn't figure it out.

Though they continued to work together, she separated from her husband in 2009, and began another journey of discovery – never suspecting how this adventure would turn out. It was during these turbulent emotional times that Barrett received a warning. Her doctor told her that she was dangerously overweight. So, for her health and for the sake of her children, Barrett decided to lose the weight.

Overweight most of her life, Barrett demonstrated another feat of courage and lost a significant amount of weight. "After I lost the weight, I gained an incredible amount of confidence," says Barrett.

Though Barrett and her husband eventually divorced, they continued to work together, and their relationship is amicable to this day. Eventually, Barrett decided to use the real estate license she obtained while working with East Carolina Community Development to go out on her own as a real estate broker. She now works as a broker with Coldwell Banker Spectrum Properties.

With her life heading in yet a new direction, Barrett bought a place in Cedar-wood Village. Her adventure and journey of discovery had led her to the realization that she was gay, and it wasn't long before she met and married her partner, Gail Carelli. In fact, when gay marriage was legalized in North Carolina, Barrett

and Carelli were the second couple to make it to the courthouse in Beaufort to be married. (They met the couple that was first in line, and the couples are now friends.)

Barrett was elected to the position of President of the Brandywine Owners Association (BOA) Board on June 10th. She says she's excited about the new board. "It's a blessing to be able to serve," says Barrett. "We've had some fantastic volunteers over the years". In her position as President of the Board, she wants to focus on streamlining communications, on transparency, and on accessibility. "Not to say that (these things haven't) existed in the past," says Barrett, but my "primary focus is on streamlining communications."

Barrett now seems to elegantly surf the wave of change that we call life. Science tells us that nothing is static, that nothing stays the same. Barrett seems to be at a place of peace and contentment, confident in her ability to ride whatever wave of change may come along, and she's able to do so with the grace that comes as the fruit of experience.

She says she feels like she's now "getting into" her stride and is staying "focused on seeing what comes next". She says, "Everything seems new and exciting". It seems that maintaining that excitement for life is much easier to do after you've succeeded in the journey of finding yourself.

...and if you're wondering if Barrett ever saw Ethel again, the answer is "yes". Ethel got to see the far reaching effects of her single comment so many years ago. Barrett took Ethel's advice and did something different. She chose courage not conformity.

- 4. How would your best friend describe you? Tough one...Gail said warm...she's my best friend!
- 5. You've had some challenges as we've all had. What was the challenge (if you don't mind sharing) but more importantly, what got you through/kept you going? My divorce was no doubt my biggest challenge. (What kept me going was) definitely my girls...A happy and content parent has a trickledown effect to children I think. Everything I've done is to be a better mother and a better person.
- 6. Funniest thing that's happened to you recently: It has to relate to an issue that crops up often with my work as a real estate broker....all relating to septic problems. Something about the folks I meet and the situations I've encountered just crack me up.

One of the first projects the board is attending to involves a substantial drainage issue in Reserve Green. Scott Carpenter has his finger on the pulse and repair work should begin shortly.



## Why You Need an Estate Plan for Your Digital Assets

According to the Pew Research Center, 87 percent of Americans use the Internet. This means most of us maintain at least some personal and financial information online. We pay bills online, keep contact records digitally, and rarely print a photo—because it's in our online photo album. Although this digitizing of information makes it easier to store and recall, it also presents some concerns when it comes to accounting for all of these "assets" in your estate.

#### What are digital assets?

First, let's define digital assets. These include your online financial accounts, your personal e-mail accounts, and your Facebook, Twitter, and LinkedIn accounts. The assets may or may not have a value. For example, you might own a domain name for your small business, which would have value, but the photos you uploaded to Shutterfly have sentimental value only.

#### The problem with digital assets in estate planning

With traditional estate planning, you take steps to ensure that your executor or personal representative can access the information needed to gather and safeguard your assets, contact creditors, and, if necessary, oversee your business after your passing. This can be especially challenging with digital assets, however, if you do not arrange the proper authorization ahead of time.

Your executor should be able to access information on your computer's hard drive relatively easily with the help of a technician. But this may not be the case for online accounts and data stored remotely. Even if you give your usernames and passwords to your executor or a family member, he or she may run up against service-agreement limitations that deny him or her the ability to access, manage, distribute, copy, delete, or even close accounts. Further, "unauthorized use" laws can lead to legal issues for your representatives if they are deemed to have exceeded permissible access levels.

#### New legal statute may ease access concerns

Fortunately, lawmakers are starting to pay attention. A new statute, the Revised Uniform Fiduciary Access to Digital Assets Act (RUFADAA), addresses whether and how a family member, executor, attorney-in-fact, or trustee can access digital assets. Sixteen states have already adopted RUFADAA: Arizona, Colorado, Connecticut, Delaware, Florida, Idaho, Indiana, Maryland, Michigan, Minnesota, Nebraska, Oregon, Tennessee, Washington, Wisconsin, and Wyoming. The hope is that more will soon follow. RUFADAA is different from state laws governing estate administration, powers of attorney, and trusts. It does not presume that family members and fiduciaries can access digital assets because of their relationship with the account owner. Instead, the statute requires express authorization before anyone—family member or fiduciary—may access the content of a digital asset.

#### So what can you do now to start organizing your digital assets?

- Decide how you want your online life handled after your death. Facebook, for example, allows a personal administrator or immediate family member to close the account or "memorialize" it. This may help ease your loved ones' pain during a time of grief. Consider creating instructions for a family member to do this, or something similar, on your social media accounts. You may assign different roles to different people. For example, you may decide to appoint one person as your executor and another to have access to certain social media accounts.
- Create a comprehensive inventory of your digital assets. Be sure to store this inventory somewhere other than an e-mail account. Some e-mail providers, like Yahoo!, will close an account that has been inactive for several months and delete the e-mail history. Even if an executor promptly contacts the e-mail

provider, he or she may not be able to copy important e-mails or contact lists before the account is deactivated. Back up important information elsewhere and update it regularly.

- Don't assume your digital estate has no value. Some frequent flyer points are transferable after your death. Credit cards with cash-back feature stores are generally redeemable after your death, but only if they are claimed. Internet domain names are potentially sellable, and blogs are a form of intellectual property.
- Consider investing in a password manager. Sites such as LastPass and Dashlane maintain a record of your online accounts and passwords in a digital safe. You can set them up to transfer the passwords to your representative at a specific event, such as your death or incapacity.

How can you ensure that fiduciaries and family members have access to your assets?

- Ask your attorney about inserting provisions into your will that grant your executor the authority to access your non-financial digital assets and accounts.
- Talk to your attorney about adding language to grant your power-of-attorney agent authority to act on your behalf with your digital accounts and assets.
- If you have assets in a trust, ask your attorney about the possibility of amending the trust agreement with language that will allow the trustee access to digital assets and accounts.
- Check online service providers' policies on death or disability. Each provider has its own access-authorization tools, and the terms vary, so be sure you understand who can and can't access information. If the provider allows access to your executor, trustee, or power-of-attorney agent, inform these individuals where important information is stored.

One final note: Be careful if you include provisions covering digital assets in your estate planning documents and complete a provider's access-authorization tool. The provisions in the documents should match the information you give in the provider's access-authorization tool. If they don't, the provider likely will follow the instructions you gave in its access tool and not your estate plan.

#### Community Spotlight: C.O.A.C.H. Hope

While some people claim that our youth are in trouble and no one is doing anything about it, a dedicated group of local mentors is determined to provide guidance and mentoring to youth at West and East Carteret High Schools. Calling their program C.O.A.C.H. Hope and focusing on the high school football and wrestling teams, Director Felicia Barrow and her volunteers are providing life changing counseling to some of our county's most disadvantaged young men.

Shad Barrow, associate pastor at Glad Tidings Church has spent the last 4 years working with team members at West Carteret, often counseling groups of up to 85 youth. His work teaching life skills and giving advice for making good choices and getting an education have made a difference for many of the young men in his program. The program is completely voluntary for the students and is not an official program of the school. Pastor Barrow is available to any student who seeks his counsel and the coaches often ask him to make motivational presentations to the teams. His position is not religious in nature, and he and his volunteers are not to preach, but to teach.

C.O.A.C.H. Hope is seeking local business and individual sponsors for the program. For example, Summer Flowers Ricketts of the Sports Center has offered 20 membership scholarships for disadvantaged students. To qualify, they must be members of C.O.A.C.H. Hope, maintain a 2.5 GPA and stay out of trouble. Local businesses and individuals are encouraged to find ways that they can support the program with mentors, financial support or incentives.

## Pet Docs Disaster and Storm Preparation & Your Pets

The best way to protect your household from the effects of a disaster is to have a disaster plan. If you have pets, that plan must include your pets. Being prepared can save their lives.

The most important thing you can do to protect your pets is to evacuate them too. Pets most likely cannot survive on their own, and if by some remote chance they do, you may not be able to find them when you return. If it's not safe for you to stay behind, then it's not safe to leave pets behind either.

Every pet should be microchipped as a permanent form of identification. A microchip is implanted in the animal's shoulder area, and can be read by scanner at most animal shelters.

#### Know a Safe Place to Take Your Pets

- Contact your veterinarian for a list of preferred boarding kennels and facilities.
- Make a list of boarding facilities and veterinarians who could shelter animals in an emergency; include 24-hour phone numbers.
- Ask your local animal shelter if they provide emergency shelter or foster care for pets.
- If you are going to a public shelter, it is important to understand that animals may not be allowed inside. Plan in advance for shelter alternatives that will work for both you and your pets; consider loved ones or friends outside of your immediate area who would be willing to host you and your pets in an emergency.
- Contact hotels and motels outside your local area to check their policies on accepting pets and restrictions on number, size and species. Ask if "no pet" policies can be waived in an emergency. Keep a list of "pet friendly" places, including phone numbers, with your disaster supplies.
- Ask friends and relatives outside your immediate area if they would be willing to take in your pet.
- Develop a buddy system with neighbors, friends and relatives to make sure that someone is available to care for or evacuate your pets if you are unable to do so. Be prepared to improvise and use what you have on hand to make it on your own for at least three days, maybe longer.

#### Pet Emergency Preparedness Kit


Keep your pet's essential supplies in sturdy containers that can be easily accessed and carried (a duffle bag or covered trash containers, for example).

Your pet emergency preparedness kit should include:

- Medications and medical records (stored in a waterproof container) and a First Aid kit.
- Make sure identification tags are up-to-date and securely fastened to your pet's collar. If possible, attach the address and/or phone number of your evacuation site. If your pet gets lost, his tag is his ticket home.
- Sturdy leashes, harnesses, and/or secure carriers to transport pets safely and ensure that your animals can't escape.
  - Current photos of your pets in case they get lost.

- Food, drinkable water, bowls, cat litter/pan, and manual can opener.
- Information on feeding schedules, medical conditions, behavior problems, and the name and number of your veterinarian in case you have to foster or board your pets.
  - Pet bed or toys if easily transportable.
- All of the information mentioned (records, photos, etc.) can often be stored on a smartphone for backup, or even on a cloud-based note service, so that the information can be accessed from any computer in the event you lose your hard copies or your smartphone.

With some preparation, you need not panic or find yourself without options when it comes to storms and storm evacuation.

### Kitchen Gadget #7:

#### **Ball FreshTECH Automatic Home Canning System**

We enjoy growing a garden in the summer. We grow lots of tomatoes, peppers, and cucumbers in particular. These ingredients are great for canning, and we could not possibly eat all the vegetables while they were fresh, so we started making canned tomatoes, pickles, salsa, and pepper jelly. It is a lot of fun to see the pretty jars all lined up in the pantry, and it's so nice to pop open a jar of garden tomato salsa in the middle of winter.

However, after 3 years of canning, we realized that 1) the water bath method of canning on our stovetop was imprecise, time consuming, and slightly dangerous, and 2) we were spending an inordinate



amount of time making canned tomatoes. So we started looking for gadgets to help improve the process, and that's when we found the Ball FreshTECH Automatic Home Canning System.

This is a large gadget that has pre-set programs for canning a variety of vegetables. To use this gadget, simply plug it in, fill it up with a few inches of water, and put in your empty jars inside to be sanitized. After the 12-minute sanitation is finished, fill your jars with food, place the lid, screw on the ring, and put the filled jars back into the machine. Lower and lock the lid, and then press three buttons to indicate the recipe you are using and start the canning. The program time displays on the front and a nice little song plays when the process is complete. Then you can lift the lid, carefully remove your perfectly canned food, and set the jars on a rack to cool. Later, test the lids to make sure they are sealed.

The FreshTECH auto-canner comes with a recipe book that has basic recipes for making salsa, tomatoes, pickles and jelly. The Ball company recommends only using the recipes in the book with the auto-canner because the pre-set programs are timed specifically for those recipes. This is fine for us because we really just want to make basic recipes. However, if I'm being honest, the pickle relish recipe I make is not in the recipe book. I found another approved relish recipe, and use the program code for that one when I make my relish. It seems to be fine. Even so, more creative or experienced canners may find that this gadget is not versatile enough for their needs.

Another option that is available now is the Ball FreshTECH Electric Water Bath Canner and Multi-Cooker, which is also an electric countertop gadget. I don't have any experience with this one, but the difference seems to be that there are no

pre-programmed recipe settings, and for canning, it uses a true water bath method. For someone who likes to get creative with their canning and/or prefers gadgets that are multi-functional, this one may be a better choice.

This month's recipe is from the Ball FreshTECH Automatic Home Canning System recipe book. You can use homecanned pickles or storebought pickles to make this tasty sauce.

#### Grilled Salmon with Bread and **Butter Pickles**

#### Ingredients:

4 salmon filets 12 bread & butter pickle slices 2 tbsp chopped bread &butter pickles 1 tbsp minced onion

#### Directions:

- Grill 4 salmon filets brushed with oil over medium heat 5-7 minutes or until fish just begin to flake, turning once
- Serve on a bed of bread & butter pickle slices.
- Top with tarter sauce. To make this sauce, combine mayonnaise, chopped bread & butter pickles, and minced onion.

#### **Restaurant Review** Moore's Olde Tyme Barbecue

Our first visit to Moore's Olde Tyme Barbecue was on a Saturday evening, around 7:30pm. When we arrived, one of the employees was just taking down a sign that said "We have ribs today." So, tip #1 is for rib eaters: go early if you want to get some ribs on a Saturday.

At Moore's, you can order at the drivethru or go inside. If you go inside, you will place your order at the front counter. We decided to dine in, and when we arrived there was no one in line; two cashiers were ready to help us. The menu includes Eastern NC barbecue, fried seafood, chicken, and sides. You can get plates with a meat and sides, combination plates, and family meals. A kid's menu is available, as well as dessert options. If you are feeding a crowd, you can order your favorites in bulk; Moore's offers



catering services as well. Tip #2 is for folks like me who have a hard time deciding under pressure: review the menu in advance online so that you already know your order when you arrive.

After paying for our meal at the counter, we selected a place to sit. There are two options for seating: a booth or a table. We chose a booth, and it was roomy and comfortable for four people. The high walls around the booth made it easy to hold a conversation, even though the dining area is large, with high ceilings. Small tables are available, as well as a long table arrangement for big groups. If you tend to get cold in restaurants, well, you already take a sweater with you everywhere you go anyway...but you may need it here.

Even before our food was delivered, a server checked on us to make sure we were comfortable and to ask if we needed anything while we waited. Then just a few minutes later, another server approached our table with our meals. We were hungry, so we did not waste any time adding the vinegar sauce to our barbecue and digging in! The food tasted fresh and really delicious.

We liked that the barbecue was chunky and had a hearty texture; it had some spicy heat, but not too much. I approved the cole slaw, as it was not too sweet and not too runny. My dining companion approved the hush puppies; they were crispy on the outside and soft on the inside. The green beans were tasty, and we noted that they had some barbecue chunks mixed in for more flavor. Another dining companion ordered BBQ chicken, and he reported that it was a little spicy (in a good way), and also a little messy - but very tasty. Tip #3 is for non-fried chicken eaters: don't miss the fact (as I did) that you can get the 1/4 chicken baked, with BBQ sauce, or fried. Next time, I'm going to get the baked chicken!

On the way out, we stopped at the hand-washing sink and noted that it was a pretty fancy sink, with a bronze faucet and a granite top. We also enjoyed taking a moment to look at the olde tyme black-and-white photos that were decorating the walls. We left feeling full and happy.

### Life As Art – and Creativity as a Key to Living Well: Exercise Your Creativity and Revive Your Inner Artist

Ahhh, summer – time outside on the water, at the beach, lounging at the pool, grilling on the deck. It's a time where we think a little more about relaxing and moving at a slower pace. We're fortunate to live here on the Crystal Coast where we have the "best of the best" that summer has to offer.

The good news is that the natural capacity for creativity is there and just needs to be nurtured. It is a style of thinking with certain characteristics, and it can be learned. (3)

If you look around Carteret County, you'll see that the arts are alive and well, which provides plenty of opportunity to explore, experience and enjoy the arts – whether you think of yourself as an artist or not, whether you want to participate or simply spectate.

Art is all around us...and it's some of this "every day art" that's gained our area certain fame. (Think of our waterfowl carving and boat building. At the Core Sound Waterfowl Museum & Heritage Center, they also display local quilts. Again, another form of art.)

In addition to the accepted forms of art, or what we typically think of as "art" – art comes in many forms since art lives within the larger field of creativity. Art usually refers to what we think of as the artistic disciplines, but art can be a way of life. Art can refer to food, the way a table is set, the way someone puts together an outfit, the way a waitress does her job – and even the way you live your life.

Boardwalk: The boardwalk along the beach has been expanded and extended. It is now an attractive feature of the area, providing beach access and other amenities. Along with the safety tips listed below, Nancy urges families to promote and teach fireworks safety by using fireworks responsibly and setting a good example for children, young adults, friends and family. Have a designated shooter that knows each firework; how it performs and how to safely light the firework. Make your backyard celebration not only a fantastic show for the family, but a teaching lesson for every-



one present. Let this 4th of July celebration be the happiest and safest celebration ever. You can visit the National Council on Fireworks Safety website for a complete list of safety tips and videos at www.FireworksSafety.org. Please follow these common sense

safety tips:

• Parents and caretakers should always closely supervise teens if they are using fireworks.

- Parents should not allow young children to handle fireworks.
- Alcohol and fireworks do not mix. Save your alcohol for after the show.
- Do not hold a firework in your hand unless specifically stated in the caution label.
  - Fireworks should only be used outdoors.
- Always have water ready, both in a bucket and in a charged hose, if you are using fireworks.
- Have a Designated Shooter for the fireworks and make sure he/she reads the caution label before igniting.
  - Obey local laws. If fireworks are not legal where you live, do not use them.
  - Wear eye protection (safety glasses) whenever using fireworks.
  - Only light one firework at a time.
- Never relight a "dud" firework. Wait 20 minutes and then soak it in a bucket of water.
- Used fireworks should be soaked with water and placed in a nonflammable trash can outside; several feet away from a house, garage, deck area or anything else flammable
- Do not use homemade fireworks, professional fireworks or illegal explosives; they can kill you!
- $\bullet~$  Report illegal explosives, like M-80s and quarter sticks, to the Police or Fire Department.


## **Brandywine Book Club Notes**

## The 2-in-1 Tryout

I don't know about you other long-haired folks, but shampooing and conditioning my hair takes a while. For years, I had been skeptical of 2 in 1 (and those dumbfounding 3 in 1, or 4 in 1) products, believing that they would make my hair too greasy. But all that changed when I



graduated from college, and accepted a summer position as a Communications Assistant for Camp Albemarle. I knew that I would have much less time to shower in a camp environment than I would in my own apartment, so I decided to give 2 in 1 shampoo a shot to see if it would help me shower faster. This type of shampoo is also a good idea if you're trying to save money on your water and energy bills, or if you're going to be traveling to a place with a small water supply. We are blessed with easy and abundant access to clean, temperature-controlled water here in the U.S., but we shouldn't take that resource for granted.

So before I moved to camp, I got a bottle of Aveeno "Pure Renewal" 2 in 1. It was the first brand I tried, primarily because I got it for free, but I felt comfortable using it because Aveeno has an established reputation as a brand for being natural and healthy. I hoped that those characteristics would translate into clean and healthy hair, sans the greasy-chic look. This product definitely saved me time in the shower, and it didn't weigh down my hair or dry it out. I honestly don't remember being overwhelmed by the quality of the product, but I think I liked it better than I thought I would.

Soon after that summer, I tried the Herbal Essences "Hello Hydration" 2 in 1 while at a friend's house. I loved the scent, and I still remember being surprised by how soft it made my hair- even while it was still wet! It made my hair look so shiny and healthy. So once my Aveeno was gone, I went out and bought a big bottle of Herbal Essences. I continued to have a good experience after multiple uses. But after buying the large bottle a couple of times, I noticed that Garnier Fructis made an even bigger bottle of 2 in 1 at a cheaper price!

The Herbal Essences "Strength & Shine" (comes in a lime green bottle) also has a really nice, and long-lasting, scent. The only downside is that I don't think it conditions as well as the other Herbal Essences product does. I have used two large bottles of this, as well as two small bottles of Garnier's "Grow Strong" 2 in 1 (which comes in a teal bottle), but I always end up feeling like my hair is just a little dry. So while it is a better deal, I don't know if I will continue to use it.

In fact, my Garnier is running low, so I just bought a bottle of Suave 2 in 1 "Plus" to try next. Suave has the largest amount of fluid ounces for the least amount of money out of all the brands I've mentioned so far, and it smells really good in the bottle. I hope that it makes my hair feel as healthy and soft as the more expensive brands do


Here's a word of warning if you're interested in doing your own 2 in 1 research. There are a lot of options out there, and certainly not every brand will work well with every hair type. Additionally, most critics seem to agree that 2 in 1 should be used as part of a balanced hair care regimen. They say you should use separate shampoo and conditioning products every once in a while, so as to prevent a build-up of chemicals in your hair. And if you do start to notice some negative effects in the health of your hair (making it either overly dry or extra greasy) due to using 2 in 1 shampoo for extended periods of time, try using a "clarifying" shampoo.

Noreen asked for a motion to accept the minutes as written from the May meeting. Nancy made the motion, Andy seconded and all approved.

Treasurer's Report: Bob went over the budget and reported that all but 15 people had paid their homeowner's dues and 14 homeowners had promised payments forthwith. One property is heading into foreclosure and Bob will monitor for sale to see if some dues can be recouped. \$223,000 is the total annual amount of income for homeowner's dues. With some bank interest and road assessment income, the annual budget amount is \$231,200. If the board adheres to the budgeted amount, no savings will be touched. Discussion was had to move some money into different line items to accommodate new camera purchases and recreational area improvements. Bob mentioned that there is still confusion regarding dropping of HOA dues in the Brandywine Mailbox. The Mailbox is located directly behind the Hwy. 70 gatehouse. Please do not deliver your HOA dues to the Golf and Shore office. The board will be putting a new sign on the HOA mailbox for everyone's attention.

Street Reps Update: Nancy reported that Faye Bennett met with current and new street reps on Tuesday evening, June 6th, at Cedarwood Clubhouse. The turnout was better than expected and Faye got all the relevant details to update her database. Notifications from the board will be sent to the street reps for dissemination to all homeowners and renters in an effort to improve communications. Signs on BOA property-implementation of covenants: The board will be discussing this in more detail with the ACC committee to ascertain compliance timelines.

Gate Card Audit: Linda Chidsey is getting up to speed with the database and as soon as the board feels comfortable with the adjustments, the gate card audit will be completed.
