November 18th, 2019 K Club

- 1. Call to Order: The meeting was called to order at 7:00 pm. Board members present were Andy Haines, Rachel Love-Adrick, Sandra Gahlinger, and Pete Ferrin.
- 2. Approval of Minutes from October Meeting: Andy asked for a motion to accept the minutes as written from the October 2019 meeting. Sandra Gahlinger made a motion to approve the minutes, Rachel Love-Adrick seconded. Minutes were unanimously approved.

## 3. Treasurer's Report:

- e. Cameras: All Working

- g. Recreational Area: The play equipment, chairs and picnic tables have been pressure washed and sealed. The swings have repaired. Roof on the plat house needs some repair. The board voted to

transfer \$1,000 from the contingency fund to the Recreation Area to allow for repairs to the playground and to purchase mulch.
