

You've heard this before, but don't dismiss it as a cliché: pay yourself first. This means setting up automatic transfers from your checking account to your savings and investment accounts as soon as you get your paycheck. Begin by logging into your online banking platform and setting up recurring transfers. You can start small—even 5 percent is worthwhile—and gradually increase the percentage over time. If your employer offers a 401(k) match, ensure that you're contributing enough to take full advantage of this free money. Remember, even small, consistent contributions can grow significantly over time due to compound interest.

#### 2. Cut Back on Impulse Purchases

That late-night online shopping scroll that somehow ends with a cart full of stuff you didn't know you "needed" isn't helping you reach your money goals. To reel in impulse purchases, try setting aside a cooling-off period for nonessential items you're considering buying. Instead of purchasing, add them to a wish list on your phone or to a Post-it Note—and keep it out of your online cart. Then, give it a day or two. That "must-have" item might seem unnecessary after 24 hours. You can also try the 30-day rule for larger purchases, giving yourself a full month to decide if it's worth the cost. You may realize you didn't need it that much.

#### 3. Track Your Spending

To make informed money decisions, you need to know where your cash is going. Keeping track of spending helps you figure out where you can cut back and increase the funds you put toward your goals. Start by choosing a way to record your purchases, whether it's a budgeting app, a spreadsheet, or just an old-fashioned notebook. Record every expense, no matter how small, for one month. Then, go over your spending patterns and figure out where you can make cuts. You might find some surprises, like buying coffee, snacks, or a daily lunch salad add up to a vacation's worth of cash over time. Use this information to create a practical, goal-centered budget, and continue tracking to ensure that you're sticking to it.

### 4. Get Familiar with Your Credit Report

Your credit score affects everything from loan approval to interest rates, so it's a

major factor in your financial life. Make it a habit to check your credit report regularly to catch errors and find ways to improve your score.

Hot tip: Every 12 months, you're entitled to one free credit report by mail from each of the three major credit bureaus (Equifax, Experian, and TransUnion) through annualcreditreport.com. If you set a reminder to request one report every four months, you'll have a year-round overview of your credit. You can also receive free weekly online credit reports through the same site. What should you be on the lookout for? Any unfamiliar accounts, incorrect balances, or payments that mistakenly show they were late. If you find issues, file a dispute with the credit bureau as soon as possible. Regularly monitoring your credit can also help you discover identity theft early.

#### 5. Stick to It

It's not always fun or easy to stick to a financial plan, but consistency is key when it comes to money matters. Developing discipline helps you stay on track, even when you spot a great sale or find a must-have collector's item. Start by setting clear, achievable goals. Write them down and keep them somewhere you'll see them often, like your fridge or as a phone background. Break larger goals into smaller, manageable steps. If you want to save \$5,000 for an emergency fund, for instance, set monthly or weekly savings targets. Create accountability by sharing your goals with a trusted friend or family member. When you're feeling discouraged or tempted, remind yourself that your long-term financial success is worth it.

Developing strong financial habits is a marathon, not a sprint. It's about making small, smart choices each day. It requires patience, persistence, and a willingness to learn from both successes and setbacks. Start by choosing one or two habits to focus on, and gradually incorporate the others as you become more comfortable.

# Final Report of Investigative Work by the Brandywine Bay Water Task Force

On November 13, 2023, at a BOA Meeting several homeowners voiced concerns about the water quality and the water price from Carolina Water Inc. (CWS). Scott Mason, President of BOA suggested that the homeowners get together and investigate a "fix" to the issues.

Nick Viglianese invited interested attendees to sign up and help with the investigation. A total of 19 homeowners signed up and shared their concern and desire to help fix the issues.

The Water Task Force was organized and began their work toward investigating a path toward cleaner, more affordable water. The task force to date has analyzed the cost of the water and analyzed bills for the neighborhood. We have challenged the price increases we have received and those that have already been approved for the future. We created a survey to determine the severity of complaints and to narrow down the

major complaints. The survey results have been shared with both CWS and Public Utilities (Utility Commission (UC))

We met with Carolina Water Services Inc on July 9, 2024, and voiced our concerns with them. They explained to us that the water rate will not be reduced, it will continue to be increased. Their reason for the high prices is because they are a state and locally taxed private water company and cannot receive Federal or State Grant Money to help offset their prices. CWS also explained the reason for the change in our water quality is because they are only concerned with Primary Water Quality i.e., bacteria and drinking safety. The color, smell and taste are secondary issues, and the state doesn't require them to meet specific criteria for secondary water quality nor does it allow

costs associated with these improvements to be included in their rate structure.

Note: CWSNC owns 300 water systems like BB's and 30 sewer systems. For the most part, these systems are all lumped together, and rates are determined in a "uniform rate." CWS pointed out BB has a net rate benefit since the \$14 million for our new sewer plant is shared among CWS' 30 sewer operations.

The water system was purchased by CWS in 1986, and at that time, the system had a working water softener. Around 2012 the water softener stopped working and, because this is a secondary water issue, it was not fixed. We have argued the fact that if the original system had a working water softener they should have fixed the water softener to keep to our expected standards. They have offered to install a softener and pass the cost on to the homeowners as an assessment. We are waiting to hear authoritatively what that cost would be.

We have gotten our water tested at the bulkhead and at a residence to determine if the quality is due to the pipes coming into our home or the water that is coming out initially. We have determined there is not a problem with our pipes, just the lack of treatment by CWS.

We met with the Utility Commission Public Staff: Water, Sewer, Telephone Division in Raleigh on October 17, 2024. Our purpose of this meeting was to voice our concerns about our water quality and increasing costs. The Public Staff heard our concerns and will be following up to determine what can be done to bring the quality of water that is expected by Brandywine consumers.

Overall, the Water Task Force has explored how to get the water quality that we deserve and how to reduce our overall costs. We have been digging deep and hard in search of facts to gain knowledge. We have searched for the most efficient, least costly and most practical strategy to resolve these issues. We are awaiting replies to follow up items from Carolina Water and the Utility Commission Public Staff, and those items will be tracked.

At this point, the Water Task Force has explored the options to improve water quality and cost. Because we have a monopolistic water provider

we are at their mercy. We have made our concerns heard to both CWS and Utility Commission. Hopefully we will see some improvements in the near future. In the last 10 years our water quality has gone down, the average family water bill, using 4000 gallons of water per month, has increased from \$76.95 per month to \$194.83 per month...an increase of 253%... all approved by the UC. Their last increase was for a water cost increase of 18% and a wastewater increase of 37½% to be spread over 3 years...2023 through 2025. We can expect more to come as the system gets older.

We get charged for water we don't use, leaks that they cause, Meters that read in both directions, meter readers that constantly misread the meters and problems that they cause...we are at their mercy.

Conclusions/Recommendations:

- 1. BB is at a huge disadvantage trying to engage and negotiate cost and water quality issues given the vastness of the CWS enterprise and the bureaucratic nature of government oversight which is at a loss to exercise any meaningful advocacy on our behalf. Water Task Force investigative efforts conclude further routine action relating to Carolina Water or the Public Utilities Commission should be done by an official function within the HOA.
  - 2. BB's options are:
- A. Wait for the PS to respond with possible improvements to water quality and what those costs to us consumers might be.
- B. Continue the efforts by Scott Carpenter and his neighbors in contact with CWS personnel to correct drainage and other issues associated with the sewage plant.
- C. Engage in a long process of energizing our political representation in the NC Assembly to enhance oversight and change some legislative roadblocks to keeping cost down. We are disadvantaged by the requirement of our private company provider to pay various taxes which are simply passed on to us consumers while our neighbors who have municipal providers enjoy tax-free status service reducing their rates.
- D. Additionally, again in a lengthy process, engage our Congressional representatives to allow us BB taxpayers to enjoy benefit from consumer cost reducing Federal grants allowed to our municipal friends.
- E. The only other option: annex to a tax-exempt service provider of water and sewer which would overcome the above rate issues and put us closer to political decision makers giving us much improved opportunity to impact water quality and cost issues.
