 - iii. Questions: Ditch spraying schedule for 309/310 Lord Granville, Drainage cover at 203 Lord Granville. Follow up Pending.
 - c. ACC: Committee working on resident requests for pools and rule violations
 - i. Question regarding enforcement of 7-day rule for trailers and boats. Topic needs to be further discussed to determine storage options for residents or covenant changes.
 - ii. Soundwaves article to be published to remind residents of regulation
